RESOLUTION No. /2024 of the Annual General Meeting of Powszechna Kasa Oszczędności Bank Polski Spółka Akcyjna of 28 June 2024

on approving the Consolidated financial statements of the PKO Bank Polski S.A. Group for the year ended 31 December 2023

Pursuant to Article 395 § 5 of the Commercial Companies Code, the Annual General Meeting adopts the following:

§ 1.

The Annual General Meeting approves the Consolidated financial statements of the PKO Bank Polski S.A. Group for the year ended 31 December 2023, composed of:

- 1) consolidated profit and loss account for the period from 1 January 2023 to 31 December 2023, reporting a net income in the amount of PLN 5 502 000 000;
- 2) consolidated total income statements;
- 3) consolidated statements of financial position as of 31 December 2023, reporting assets and total liabilities and equity amounting to PLN 501 516 000 000;
- 4) consolidated statements of changes in equity;
- 5) consolidated statements of cash flow, showing an increase in net cash in the period between January 2023 and 31 December 2023 by PLN 34 000 000;
- 6) notes to the consolidated financial statements.

§ 2.

This resolution shall come into force as of the date of its adoption.

Rationale

to the draft resolution on approving the Consolidated financial statements of the PKO Bank Polski S.A.

Group for the year ended 31 December 2023

Pursuant to Article 395 \S 5 of the Commercial Companies Code, the annual general meeting shall examine and approve financial statements of the group within the meaning of the provisions on accounting and the other issues that mentioned in the \S 2 of this article.

In relation to the above the resolution should be considered at the Annual General Meeting.
