ANNOUNCEMENT OF LIMITS FOR PAYMENT TRANSACTIONS IN THE MOBILE APPLICATION

For those aged 18 and over, the maximum daily limits for payment transactions on the mobile app are:

- 1) PLN 50,000 - for transfers to an account,
- 2) PLN 3,000 - for mobile transfers,
- 3) PLN 20,000 - for transactions initiated with BLIK code, except for sec. 6,
- 4) PLN 1,000 - for transactions initiated with a BLIK cheque,
- 5) PLN 20,000 - for BLIK contactless payments,
- 6) PLN 5,000 - for deposits in cash deposit machines using a BLIK code.

For those aged 13 or over but under 18, the maximum daily limits for payment transactions on the mobile app are:

- 1) PLN 5,000 - for transfers to an account,
- 2) PLN 3,000 - for mobile transfers,
- 3) PLN 5,000 - for transactions initiated with a BLIK code,
- 4) PLN 500 - for transactions initiated with a BLIK cheque,
- 5) PLN 5,000 - for contactless BLIK payments.

For an instant transfer ordered via the electronic banking service, the maximum limits are specified in a separate message available on our website.

For those aged 18 and over - the default daily limits for payment transactions on the mobile app, are:

Withdrawal from an ATM using a BLIK code	20	PLN 1500
Payment online using a BLIK code	20	PLN 3000
Transaction at a payment terminal, withdrawal from an ATM, online payment using BLIK cheque	-	PLN 500
Transfer to account	20	PLN 3000
Payment contactless BLIK	-	PLN 3000
Payment at deposit machine using BLIK code	3	PLN 3000

For those who are 13 years of age or older but under 18 years of age - the default daily limits for payment transactions on the mobile app, are:

	Number of transactions	Amount of transactions
Mobile transfer	20	PLN 300
Transaction at a payment terminal using a BLIK code	20	PLN 300
Withdrawal from an ATM using a BLIK code	20	PLN 300
Payment online using a BLIK code	20	PLN 300
Transaction at a payment terminal, withdrawal from an ATM, online payment using BLIK cheque	-	PLN 250
Transfer to account	20	PLN 500
Payment contactless BLIK	-	PLN 500
Payment at deposit machine using BLIK code	3	PLN 500

Remember: you can change your limits at any time, but those cannot be higher than the maximum limits.

For those aged 18 and over - the maximum daily payment transaction limits for mobile app account transfers, which will apply from February 3, 2026, are:

- 1) PLN 50,000 - when you have additional e-banking security features activated in the mobile app,
- 2) PLN 20,000 - when you do not have additional e-banking security features activated in the mobile app.

What is worth to know?

The Announcement is effective from 6 May 2025 - with the exception of the maximum daily payment transaction limits for account transfers in the mobile app, depending on additional e-banking security features, which apply from February 3, 2026
